- **3. Secretary:** Candidate for the post of Secretary should be a member of the Association for at least 5 years and should have a standing at the Bar for at least 7 years.
- **4. Treasurer:** Candidate for the post of Treasurer should be a member of the Association for at least 5 years and should have a standing at the Bar for at least 7 years.
- **5. Executive Committee Members:** Candidates to the post of members in the Executive Committee should be members of the Association at least for a continuous period of 3 years.

All candidates should have attained the respective qualifications as on the date of this notification.

### **Nomination Forms**

The Nominations have to be filed in the prescribed form and submitted to the undersigned or the authorized person. The nomination forms will be available in the office of the Association from 08.12.2020 onwards between 10. a.m and 4 p.m. on payment of Rs. 100/- per form.
