



Respected Sir,

The Covid-19 vaccine has been decided to be made available to all persons above 45 years from 1<sup>st</sup> April. 2021 onwards. Substantial number of lawyers, staff of the Registry and other stake holders of this institution will come under this group and therefore this Association feels that it is our responsibility to make necessary arrangements for providing vaccination to all persons interested. Since the activities of our court has to return to normalcy at the earliest, such an attempt is a real necessity. The initial vaccination drive arranged for about 100 persons including our Judges and senior Lawyers was indeed effective and the same points out to the need to make arrangements for all who come within the age group coming under the present scheme. We have learnt that the health personnel in charge of vaccination are willing to provide the same in our institution if necessary arrangements can be made from our side. Hence we request your Lordship to give necessary instructions to the Registrar General to provide all infrastructural facilities to ensure that vaccination is arranged at the earliest, if possible before the court closes for summer recess.
